



# VIRGINIA GOLF HALL OF FAME

## NOMINATION INFORMATION AND FORM

*The Virginia Golf Hall of Fame Committee wishes to obtain nominations from the general public for candidates to be considered for induction into the Virginia Golf Hall of Fame.*

### **Membership Guidelines**

To be eligible for consideration for induction into the Virginia Golf Hall of Fame, a candidate should:

- Be a native of Virginia, or a current or former resident for a reasonable period of time;
- Have distinguished himself or herself in some capacity associated with the game of golf in Virginia;
- Have brought honor to Virginia and himself or herself with sportsmanship, integrity and conduct related to the game in Virginia and/or elsewhere;
- Have a level of experience and/or acclaim in the game of golf as a consequence of any of the following:
  - Golf playing ability and record from either amateur or professional competitions;
  - Golf teaching or coaching ability and accomplishments;
  - Dedication, commitment and service to the game of golf at either the local, state or national level;
  - Recognized impact and contributions to the game of golf and the organizations that administer and promote the game in the commonwealth of Virginia.

### **Virginia Golf Hall of Fame Committee Makeup**

The Virginia Golf Hall of Fame Committee consists of nine (9) voting members. The committee includes representation from at least one member of the Virginia Golf Hall of Fame, male and female golfers from all areas of the state, allied golf organizations, avid golf historians and members of the VSGA Board of Directors. VSGA staff members serve as non-voting advisors to the committee.

### **Nomination Process**

The process by which an individual's name progresses from initial nomination to induction begins with completing the nomination form and associated paperwork. Those wishing to place names into nomination are encouraged to provide as much accurate data as possible about the individual. All fields on the nomination form and accompanying documents must be submitted in order for the nomination to be considered by the committee. All nominations will be reviewed and voted on by the Virginia Golf Hall of Fame Committee in order to determine the individuals to be inducted a future class. Once individuals have been nominated their credentials will be reviewed each year by the committee with no expiration date.

### **Voting Process**

The Virginia Golf Hall of Fame Committee will review all individuals nominated for induction. The voting process is conducted in two steps:

- (1) All nominated individuals will receive a yes or no vote from each committee member and nominees must receive at least seven yes votes to make the first cut. A yes vote means that the committee member feels that the candidate is deserving of being inducted into the Virginia Golf Hall of Fame.
- (2) All nominees that receive at least seven yes votes will be ranked by each committee member with one (1) being the most deserving candidate and the highest possible number being the least deserving candidate. A total ranking will be calculated by adding the weighted value given to the nominee by each committee member. The total rankings will be used to determine the appropriate number of inductees for each class.
